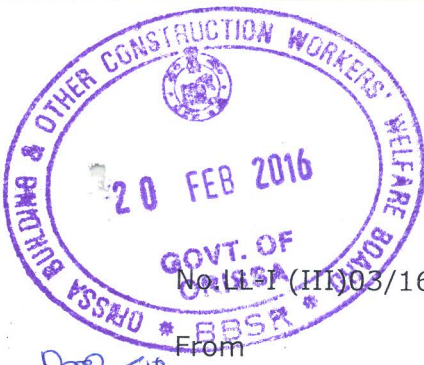


Sub:- Guidelines on Nirman Shramik Pucca Ghar Yojana under Odisha Building & Other Construction Workers Welfare Board.
