

NOTIFICATION

Bhubaneswar, dated the ~~28th~~ 29th December, 2010

No.LL-I(III)29/2010 10913 /LE., In exercise of the powers conferred by Section 62, readwith Section 40 of the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 (27 of 1996), the State Government after consultation with the expert committee do hereby make the following rules further to amend the Orissa Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Rules, 2002, namely:-

1. (1) These rules may be called the Orissa Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Amendment Rules, 2010.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Orissa Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2002; (hereinafter referred to as the said rules), in rule 270, for Para 2, the following shall be substituted, namely:-

"If disability is resulted due to accident, the Board may sanction a financial assistance to the beneficiary depending on the percentage of disability as under:-

- (A) Loss of actual physical separation or total and irrecoverable loss of use of

- (C) Permanent total disablement from injuries other than those specified in item (a) and (b) above- Rs. 20,000/- (Rupees twenty thousand) only;
- (D) In case of permanent and partial disablement as specified in the table format of the proposal the Board will decide the modus operandi to find out the genuine case for extending the benefit”.

3. In the said rule, in rule 271, for the figure and letters “Rs. 10,000/-” and “Rs. 20,000/-” the figures and letters “Rs. 25,000/-” and “Rs. 50,000/-” shall respectively be substituted.

4. In the said rules, for rule 272, the following rule shall be substituted, namely:-
“272. The Board shall introduce the National Pension Scheme of the Government of India, in which the beneficiary has to pay Rs.100/- (one hundred) per month as premium whereas the Central Government is to contribute Rs. 1000/- (one thousand) per annum. The Orissa Building and Other Construction Workers' Welfare Board shall contribute Rs. 500/- (five hundred) per annum to the fund as premium for the beneficiary. The beneficiary shall be availing pension benefits on superannuation after the age of 60 (sixty) year in accordance with the provision of the scheme.”

5. In the said rules, for rule 275, the following rule shall be substituted; namely:-
“275. The Board shall grant financial assistance for education to the children of the beneficiaries having a continuous registration for a period of one year under the Board. There shall be no financial assistance for education of children till 12th class and Bachelor degree in Arts, Science and Commerce. The financial assistance to the children of beneficiaries for their education in Government ITI and Diploma @ Rs. 1000/- (one thousand) per annum for son and @ Rs. 1500/- (one thousand five hundred) per annum for daughter and their education for Engineering, Medical and Professional PG Studies in

Government institution @ Rs. 2000/- (two thousand) per annum for both son and daughter. This assistance will be entitled upto two children of the beneficiary. The Board may also require the beneficiary to submit an application in form XLII with such documents within such time as may be specified by the Board."

6. In the said rules, for rule 276, the following rule shall be substituted, namely:-

"276. The Board may sanction for reimbursement in full for the treatment of major ailments viz. Cancer, Heart Disease, Kidney Disease and Brain Disease in Government Hospital to the beneficiary who has been registered as a beneficiary for not less than one year. The Board may also require the beneficiary to submit an application in Form XL with such documents and within such time as may be specified by the Board."

7. In the said rules, for sub-rule (1) of rule 278, the following sub-rule shall be substituted, namely:-

"(1) The Board shall extend an amount of Rs. 3000/- (three thousand) as stipend to the registered beneficiary under-going training and education for skill development."

8. In the said rules, after rule 278, the following rule shall be added, namely:-

"278A. The Board shall extend an amount of ~~Rs. 1800/-~~ (one thousand eight hundred) ~~as funeral assistance in case of death of a registered beneficiary.~~ The Board may also require the nominee of the beneficiary to submit an application in form XLIII with such documents and within such time as may be specified by the Board."

9. In the said rules, after Form XLI, the following Forms shall be inserted, namely:-
