Sub:- Enhancement of assistance / benefits to the Building and Other
Construction Workers under OB & OCWWB

Madam,

I am directed to say that Government have been pleased to allow the OB & OCWWB to implement the enhanced scale of benefits hence forthwith in exercise of powers conferred under Rule 279 of the Odisha Building and Other Construction Workers (RE&CS) Rules, 2002 as mentioned below, without waiting for formal amendment to the rules.

- The minimum period of registration for availing assistance for purchase of Bicycle is reduced from 3 years to one year.
- The minimum period of registration of one year, required for availing assistance for purchase of safety equipment, working tools and death benefit (in case of natural death), is waived.
- Daily wage compensation of Rs. 200/- per day is announced for registered workers availing training under the Recognition to Prior Learning and Skill Development Scheme for construction workers, for the training period.
- Maternity Benefit is enhanced from Rs.4000/- to Rs.8000/-
- Marriage assistance is enhanced from Rs.20,000/- to 25,000/-
- The education assistance provided by the Board is enhanced as follows:
