Sub:- Guidelines of Nirman Shramik Pension Yojana (NSPY).

Para-4.1 regarding eligibility criteria appears in the Government Resolution issued vide this Department No. 4034/L&ESI dt.24.05.2016 may be read as follows:

4.1 "A person who is a construction worker and who is validly registered with the Odisha Building and Other Construction Workers' Welfare Board, on completion of 60 years of age, will be eligible for assistance under the "Nirman Shramik Pension Yojana (NSPY)". Pension in respect of widow / physically challenged construction workers will be considered as per MBPY guidelines.

Similarly, the words 'the District Social Welfare Officer' appears in Para-5.9 of the said Resolution may be read as 'the District Social Security Officer'.

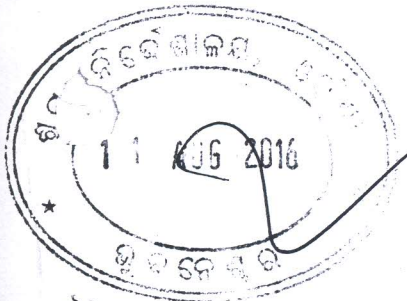
