Sub: Payment of assessment fees under RPL and Skill Development Scheme.

Madam/Sir,

Earlier MoUs have been signed by the OB&OCWW Board with the Training Providers under the RPL & Skill Development Scheme for building & other construction workers and the Assessment Bodies were submitting their bill invoices to respective Training Providers for necessary reimbursement. In this connection, some of the Assessing Bodies have raised complaints regarding inordinate delay in payment by the Training Providers, for which the work flow of the programme was hampering.

As per agreement signed by the OB&OCWWB & the Training Partners, it is the duty of the Training Provider to co-ordinate the functions of Assessment Bodies and assessment fee @ Rs.1000/- per candidate will be reimbursed by the Board vide clause No.3.9 and 4.4 of the agreement respectively.

In this connection the Ministry of Labour & Employment (DG Emp. & Trg.), Govt. of India vide letter No.DGET-4/13/2014/MES/Is dtd.13.02.2015 has issued guidelines that the Assessing Bodies shall directly raise their invoices towards reimbursement of assessment cost to the Board.

In view of the above, and after necessary consideration, the OB&OCWW Board in its 18<sup>th</sup> Board meeting have been pleased to allow that the Assessing Bodies shall directly raise their invoices towards reimbursement of assessment cost to the Board and a separate MoU would be signed to that effect with the bodies.


