**Sub: Launching of "Recognition to Prior Learning (RPL) and Skill Development Scheme for construction workers"- Regarding.**


Sir,

In inviting a reference to the above mentioned subject, I am to intimate you that the Memorandum of Understanding (MoU) was made with your organisation for implementation of "Recognition of Prior Learning (RPL) and skill development of construction workers". A part from the Training/RPL/Certification Module, you have to undertake other welfare facilities like opening of the bank account, providing Aadhar Card and providing safety equipment and tool kits to the registered construction workers undertaken training. The Odisha Building & Other Construction Workers' Welfare Board in its emergency meeting held on dtd.18.02.2015 has deferred the decision for opening of bank account and Aadhar Card for beneficiaries. So, the following points may be taken into account for smooth implementation of the Scheme.

- (i) Extension of welfare facilities like opening of bank account and Aadhar Card may not be undertaken for the time being.
- (ii) Prior intimation on onsite training programme should be given to the concerned District Labour Officer with due intimation to the Board office.
- (iii) The list of workers, to whom safety equipments/tool kits supplied, should be verified with the District Labour Officer, so that, the beneficiaries will not be duplicated or doubly benefited.


Action taken and date of launching of the training programme in the district may be intimated to the undersigned time to time.
