Inviting a reference to the above subject I am directed to say that Government have been pleased to allow the OB & OCWWB to implement the enhanced scale of benefits hence forth with in exercise of powers conferred under Rule 279 of the Odisha Building and Other Construction Workers (RE&CS) Rules,2002 as mentioned below, without waiting for formal amendment to the rules.

1. Purchase of Bicycle - upto Rs.4000/- (Rupees four thousand)only
2. Purchase of safety equipment - upto Rs.1000/-(Rupees one thousand)
3. Permanent total disability due to Accident-Rule 270(A)-Rs.1,50,000/- (Rupees One lakh fifty thousand) only.
4. Loss of one limb/eye - (Rule 270(B)-Rs.80,000 (Rupees eighty thousand) only.
5. Permanent disability without loss of two limbs/eyes-Rule 270©-Rs.40,000/- (Rupees forty thousand) only.
6. Death Benefit- Rule 271 - Rs.1,00,000/- (Rupees one lakh)only
7. Death due to Accident- Rule-271 - Rs.2,00,000/-(Rupees two lakh)only
8. Educational Assistance per Annum,Rule-275 -

Rs.4000/-(Rupees four thousand)only, daughter
For B.A /BSc/B.Com & P.G- Rs.4000/-(Rupees four thousand)only, Son

For ITI/Diploma/Polytechnic/Engg/Medicine-At parwith fee structure
decided by Govt and Rs.2400/- additional for daughters only.
9. Funeral Assistance-Rule 278-A- Rs.5000/-(Rupees five thousand)only
10. Skill upgradation Training, Rule 278(1)-Rs.2000/-PM(two thousand)
only for maximum 6 months.
11. Maternity benefit, Rule-277 - Rs.4000/- (Rupees four thousand)only
12. Marriage Assistance - Rs.10,000/- (Rupees ten thousand) only.
